# The Fine Print

#### PICOLATA CROSSING ELEMENTARY APPROVED VOLUNTEERS

1). All individuals or companies that wish to come onto Picolata Crossing Elementary campus must be cleared as an approved volunteer. Please fill out the online application using the link below, choose Picolata Crossing Elementary (and any other school you wish is volunteer for). We will be notified when you are cleared. Please note that this process can take 2-3 weeks but once you are finished, you are cleared for 3 years!

Please be certain to provide your complete LEGAL first, middle, and last name (no nicknames), birth date, social security number, driver's license number, complete mailing address, and phone number when filling out your application. Incomplete applications will not be processed. By completing an application you are agreeing to a criminal background check and a sexual offender check. You are also agreeing to abide by the policies and procedures of the St. Johns County School Board and its facilities while volunteering. Your personal information will be kept confidential and you are expected to keep any and all information you may see or hear while volunteering confidential.

The St. Johns County School District reserves the right to restrict and/or deny a person's volunteer privilege when deemed necessary.

#### ST JOHNS COUNTY APPROVED VENDORS

2). All Individuals or companies that wish to sell product or provide a service (I.e. onsite catering, food vendor at carnival, etc) at a school event in St. Johns County must be approved as a vendor in accordance with the Jessica Lunsford Act. Going through this process gets you on the approved vendor list for St. Johns County and therefore access and availability to all schools in the district. This vendor clearance is good for 5 years.
